# **Roads:** (Michael Tucker)

- For the Month of May
  - General maintenance and grading was performed
    - Reconstructing the hill on Skyline to improve drainage
    - Upcoming Culver pipe maintenance/replacement projects is scheduled
    - Ginseng and Pinnacle-> Work will be done to the area that is washing out on the lakeside. We will increase the size of the culvert pipe.
    - Lakeview Trial-North-> Road washed out. Rebuild and redirect the water
    - Pothole maintenance will be scheduled

## **Security:** (Mark Hodge)

- Problems in many areas of the lake
  - Unregistered vehicles and boats
  - Utter chaos as people put their boats in the docks
  - An emergency requiring an ambulance
  - Drunk Driving incident; Two auto accidents-both on the outer road
  - Imposed a \$125 fine to 4 wheelers that were on the Dam
  - False information given at the gate upon entry
  - Guest entering through the north gate: speeding
  - Guest harassing guards
  - Hired 2 guards (Frank/DeLisa)
  - Camera have been updated to HD
  - Guard Shack Store-Many new items
  - Dumpsters- Residents/guest are dumping much more than trash causing a problems
  - Problems in the north gate area including break-ins, firearms discharged
  - Trying to find a balance as to how we handle violations- Needs to be discussed

#### **Architecture:** (Rick Martin)

- 5 Permits approved
- 4 new request pending

# **Special Projects:** (Dan Latham)
