## **Pinnacle Lake Estates Specially Called Meeting** **October 11, 2025** **9:00 AM at the PLE Pavilion**

The Pinnacle Lake Estates Board of Trustees are requesting lot owners to attend a Specially Called Meeting, to take place on October 11, 2025, at 9:00 a.m. at the PLE Pavilion, 102 Skyline Drive South, New Florence MO 63363. The purpose of this meeting is to vote on the proposed Annual Assessment increase.

The PLE Board of Trustees is requesting that lot owners vote on an Annual Assessment Increase based on cost of living. The Board is proposing a 4% cost-of-living increase each year over the next 5 years. For your convenience, the two tables below outline the information requiring approval.

Table 1 reflects the proposed Annual Assessments increase for Primary and Secondary Lots, based on the 4% cost of living adjustment. This increase will only apply if the revised Primary and Secondary Lot definition are approved at the 2025 Annual Meeting to be held on September 20, 2025.

If lot owners do not approve the definition changes. All Pinnacle Lake lots will be classified as Primary Lots, and assessed at the Primary Lot fee. In that case, the Board of Trustees will still be requesting the 4% cost-of-living increase for all lots. Please contact the office, or a PLE Board Member if you have any questions.

If you cannot attend the meeting, a proxy form is enclosed with this notice. Please ensure your proxy is notarized and returned either by mail or in person to the office by October 9, 2025. If you are unable to meet the deadline, the individual designated to execute your proxy must arrive at the meeting no later than 8:30 a.m. so it can be processed.
